Pursuant to the provisions of the Colorado Revised Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is: the CIVA School Community Coalition (If this is a change of name amendment, the name to be typed is the corporate name prior to this amendment being filed)

2. Text of the amendment adopted: Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 for corresponding provision of any future United States Internal Revenue Law.

3. The amendment to the Articles of Incorporation was adopted on the 19 day of October, 1998, in the manner prescribed by the Colorado Revised Nonprofit Corporation Act. [mark (x) applicable procedure below]:

- A. The amendment was adopted by the board of directors/incorporators without member action and member action was not required;
B. The amendment was adopted by the members AND the number of votes cast for the amendment by each voting group entitled to vote separately on the amendment was sufficient for approval by that voting group;
